


# The Origin of Addiction

Having interviewed more than 10,000 addicts, offenders, ex-offenders, people in Recovery, People "recovered" and Family Members

I've found 90% of addiction is grounded in 3 substances prior to the age of 18 – ALL 3

#### Gateway to Heroin and Fentanyl/Synthetics

- 137 Addicts were interviewed over 10 months in Camden
- Not one person was FROM Camden, 126 were Women
- 121 of them abused Opioid medication prior to becoming addicted to heroin and fentanyl/synthetics
- 88% (National accepted percentage is 80%)
- Opioids have their place, their importance, but since 1995, and throughout the later years, these drugs were mis-marketed, overprescribed and abused

#### The Tri-Fecta Gateway

- · Tobacco / Nicotine
- Alcohol at a young ageMarijuana consumption as a teen
- ONE-HALF of the Tobacco consumed in America is consumed by people with substance use disorder or mental illness
- EIGHTY % of the Alcohol consumed in America is consumed by 20% of the drinkers
- Marijuana is 600% stronger than it was just five years ago, and the average method of initiation for youth is smoking concentrates through pipes (BHO) and vapes or e-cigarettes



# Where are we 8 years later?

#### COLE MEMO of 2013

Told L.E. to focus on:

- Prevent Distribution of cannabis to minors
- Prevent cannabis revenue from funding criminal enterprises, gangs or cartels,
- Prevent cannabis from moving out of states where it is legal

#### Where are we?

- 18 States (and D.C. are fully recreational
- 18 additional states are fully medicinal marijuana
- ZERO caps in ANY state on potency and NOT ONE STATE has identical testing requirements for mold or other contaminants
- Adolescent use at RECORD HIGHS
- Potency at RECORD HIGHS
- Drugged driving at record levels with NO universal means of testing and prosecution
- SYSTEMIC Contamination in hotels, rental cars and many tourist locations

### Where are we GOING?

- 68% of voters support federal legalization, and it WILL PASS
- Jeff Bezos and Amazon fully involved in legalization discussion, the drafting of legislation and controlling distribution
- Monsanto controlling 90% of the raw materials
- Cannabis-induced psychosis, especially among KIDS
- · Cannabis hyperemesis syndrome
- Explosion in earlier onset of addiction and mental health problems, especially among kids
- Continued explosion of suicide, adolescent suicide
- A complete destruction of "recovery" drug treatment and sober living treating marijuana NOTHING like alcohol but embracing it as an "alternative to drugs"





The genetically-modified plant is itself modified again into a more pure, more potent drug





# The "CBD" industry
